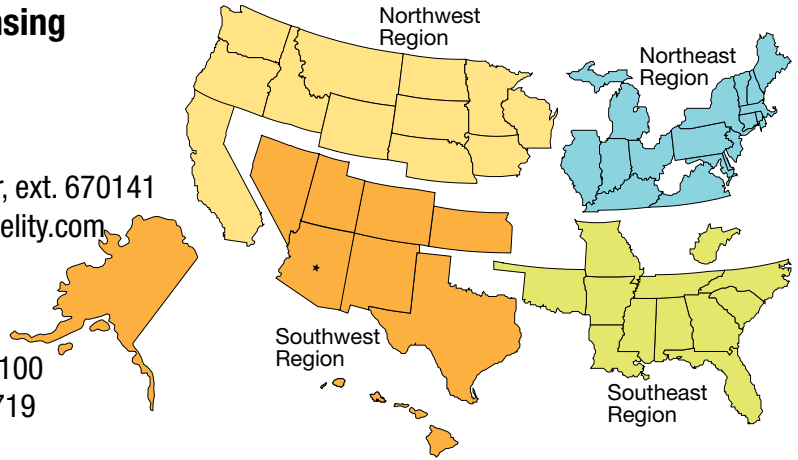

Draft Applications: Applications (with first premium draft) may be faxed to 1-888-5FAXAPP or 1-888-532-9277. Please be sure to include the EFT authorization form.

Cash with Application: Applications (with check) must be sent by regular or overnight mail. You may fax the application to start the process, however the original must be sent to the above address in order to issue the policy.

Open Enrollment: Applications received during the Open Enrollment or Guarantee Issue Period will be issued and mailed the day the application is received.

Underwriting: Applications that require underwriting are forwarded to the underwriter (ESP) the day of receipt. Policies will be issued and sent the same day as the approval is received from the underwriter.
